Staff Compensation for 2019-2020

 The CBISD Board approved salary increases last night that totaled over \$1M. They approved the Equity Center Proposal based on current House Bill 3

<u>Teachers, Nurses, Librarians &</u> <u>Counselors working 187 days:</u>

> An increase of 5.8% - 10.5% (\$3,000 - \$5,920) depending of years of service (0-29)

#### 30 + years - \$3,000

This Equalization Scale for Teachers/ Nurses/Librarians/Counselors and is based on 187 work days, meaning it calculates Teacher salaries for a 187 day contract. The daily rate will have to be multiplied by 195 days to get salaries for Nurses/Librarians/ Elementary Counselors and by 210 days for Secondary Counselors.

#### Central Administration & Campus Administration (returning):

An increase of 3% of individual salary

All Others (returning):

An increase of 4% of individual salary
