Special Board Meeting

A Special Board Meeting was called on August 3, 2020.

The Board approved the Operation Connectivity Interlocal Acquisition Agreement with Region 4 Education Service Center for Technology Purchases

At the Board Table

- Instructional A campus update was given by each principal.
- Maintenance report Justen Williams, Maintenance Director, reported on the status of the 6th grade project at WBJH and that the Groundbreaking Ceremony is scheduled for 8:30a.m. August 19th. He gave the status of facility projects from 2019-2020 and presented a list of facility projects for 2020-2021. He also gave an update on the district's roofs and AC's.
- Financial Report Superintendent, Steve Galloway, gave the Board the student/teacher ratio for 2020-2021. He also presented budget savings possibilities for 2020-2021.
- Athletic Department Brent Mascheck, Athletic Director, discussed the "new norm" for athletics. They start the day taking each student's temperature before they are allowed to dress out and begin practice. Their main focus is the safety of the students. This year he has 107 playing football, 43 in volleyball and 12 in cross country.
