- Prior to the meeting a public hearing was held on proposed budget for 2021-2022. Jason Tracy, Chief Financial Officer, discussed the proposed budget for next year.
- Instructional Report - Steven Galloway, Superintendent, reported on the State Testing results for CBISD.
- Maintenance Report - Justen Williams, Director of Maintenance, reported the 6th grade building at WBJH has been completed. All fence and a temporary irrigation system for the sod has been installed at WBJH.
