- Maintenance Report Justen Williams, Maintenance Director, discussed the District Roof Assessment report and chillers at WCE.
- Safety Report Steven Galloway, Superintendent, gave a Covid update. Student isolation requirements have changed. Students will be required to isolate for 5 days instead of 10. Students must be fever free and have improved symptoms before returning. The Governor Summer Safety requirements have been completed. Doug Sanders, Chief of Police, reported on the Active Shooter Training and beginning of the year protocols. William Jeffery, Principal Columbia High School, gave a report on how CHS will facilitate the seniors being allowed to have off campus lunches.
